Re: Miscellaneous Automobile Classification Codes – Motor Homes and Trailers

It has come to our attention that the class codes set forth for Motor Homes and Trailers are currently only listed in the Private Passenger section of the NISS Automobile Statistical Plans.

These Miscellaneous class codes for Motor Homes and Trailers should also be used when this type of risk is written on a commercial policy. As such, we are adding these class codes to the Other Than Private Passenger section of the NISS Automobile Statistical Plans.

The class code additions are shown in detail on the attached pages.

The coding on the attached pages will be reflected in the 2nd Quarter 2016 revisions to the NISS Automobile Volume I and Volume II Statistical Plans.
