Re: Assigned Risk Automobile Nonbinary Classifications – Virginia

AIPSO announced that the Virginia State Corporate Commission Bureau of Insurance has approved revisions to the private passenger automobile classifications to accommodate applicants who designate their gender as nonbinary.

Youthful operators with a gender selection of nonbinary will be assigned the same classification code as a youthful male.

NISS is revising the classification charts for Assigned Risk Automobile experience in Virginia to reflect the above revisions, as shown on the following page.

These changes apply to new and renewal policies effective July 1, 2020 and subsequent. The coding on the attached pages will be reflected in the 3rd Quarter 2020 revisions to the NISS Automobile Volume I Statistical Plan.
