Transportation Network Companies (TNC)

The Commissioner of Insurance in North Carolina has approved amendments to the Personal Automobile Policy Program to introduce coverage for drivers providing services for Transportation Network Companies (TNC).

As a result, NISS is adding TNC classification codes as shown on the attached page for North Carolina Private Passenger Automobile experience.

These changes are effective on all new and renewal policies effective on or after July 1, 2016. The attached pages set forth the changes as they will appear in the 3<sup>rd</sup> Quarter 2016 revisions to the NISS Automobile Volume II Statistical Plan.
