- Re: Assigned Risk Automobile Nonbinary Classifications California, Oregon and Washington

AIPSO recently announced revisions to the private passenger automobile classifications have been approved to introduce youthful nonbinary classifications for the states of California, Oregon, and Washington.

Automobile Insurance Plan Manuals for these states have been revised to include the following definition: 'Nonbinary' means a person whose gender identity is not specified or falls outside the traditional conceptions of strictly either female or male. Any youthful operators who identify as nonbinary will receive the same rating classification as a youthful female.

NISS is revising the youthful operator classification charts for Assigned Risk Automobile experience in California, Oregon and Washington to reflect the above revisions, as shown on the following pages.

This change applies to new and renewal policies effective January 1, 2019 and subsequent. The coding on the attached page will be reflected in the 1<sup>st</sup> Quarter 2019 revisions to the NISS Automobile Volume I Statistical Plan.
