Re: Assigned Risk Automobile Nonbinary Classifications – New Jersey

AIPSO announced that the New Jersey Department of Banking and Insurance has approved revisions of the private passenger automobile classifications to accommodate applicants who designate their gender as unspecified.

Youthful operators with a gender selection of nonbinary will be assigned the same classification code as a youthful female.

NISS is revising the classification charts for Assigned Risk Automobile experience in New Jersey to reflect the above revisions, as shown on the following pages.

To satisfy AIPSO's requirement that the nonbinary exposures be separately identified, we are also adding the Nonbinary Code in the NISS Automobile Volume II Statistical Plan for New Jersey. Nonbinary Code should be reported in position 79 of the NISS record layout for the ARP and ARPEX Calls.

These changes apply to new and renewal policies effective November 1, 2022, and subsequent. The coding on the attached pages will be reflected in the 4<sup>th</sup> Quarter 2022 revisions to the NISS Automobile Volume II Statistical Plan.
