Re: Assigned Risk Automobile – Nonbinary Code for AR, CA, CO, CT, DC, ME, NV, OR, UT, VA, VT, and WA

AIPSO recently announced the addition of a separate code to their Statistical Program to separately identify nonbinary exposures for the states that have approved nonbinary designations.

To satisfy AIPSO's requirement that these nonbinary exposures be separately identified, we are introducing a new field, Nonbinary Code, in the NISS Automobile Volume I Statistical Plan. Nonbinary code should be reported in position 79 of the NISS record layout for the ARP and ARPEX Calls. The attached pages set forth the new Nonbinary Code.

This new Nonbinary Code applies to youthful nonbinary risks in Arkansas, California, Colorado, Connecticut, District of Columbia, Maine, Nevada, Oregon, Utah, Virginia, Vermont, and Washington. All other experience should leave this field blank.

These changes apply to new and renewal policies effective January 1, 2021 and subsequent. The coding on the attached pages will be reflected in the 1st Quarter 2021 revisions to the NISS Automobile Volume I Statistical Plan.
